Description

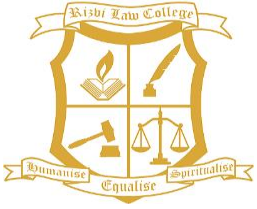

Patil (the Principal of the college), and the presidents of the Student Bar Forum Mr. Avinash Veer and Ms. Avadhi Jain, students 5th Year BLS. Following the lighting of the lamp, the honourable guest was felicitated. A total of 70 students attended the seminar.

The conference centred around the rights and legal obligations towards refugees in India. It covered topics such as the definition of a refugee, the process of seeking asylum, and the rights and entitlements afforded to refugees under Indian law. The objective was to equip the students with knowledge that would help them better comprehend the challenges faced by refugees and the legal mechanisms in place to address their needs. From the conference the students learned that refugees are people who flee their country of origin due to a well-founded fear of persecution for reasons of race, religion, nationality, membership of a particular social group or political opinion. They also learned that India does not have a specific national law or policy for refugees, but it has always accepted refugees from neighbouring countries on humanitarian grounds. However, India follows some of the principles of the Convention, such as non-refoulement, which means not sending refugees back to a place where their life or freedom would be threatened. India also cooperates with the UNHCR, the UN agency that assists refugees, and grants refugee status to some asylum seekers who are not recognized by the Indian government. India treats refugees as foreigners under its existing laws, such as the Foreigners Act, 1946, the Passport Act, 1967, and the Citizenship Act, 1955. These laws do not distinguish between refugees and other foreigners, and do not grant any special rights or benefits to refugees. Refugees in India face many challenges, such as lack of legal recognition, documentation, education, health care, employment, and social integration. They also face the risk of detention, deportation, and discrimination. India has hosted different groups of refugees over the years. The treatment and status of these refugees vary depending on their origin, religion, and political affiliation. India needs a comprehensive and consistent refugee law that can address the needs and rights of refugees in a fair and humane manner. Such a law should be based on the principles of international law and human rights, and should provide for the identification, registration, protection, and durable solutions for refugees.

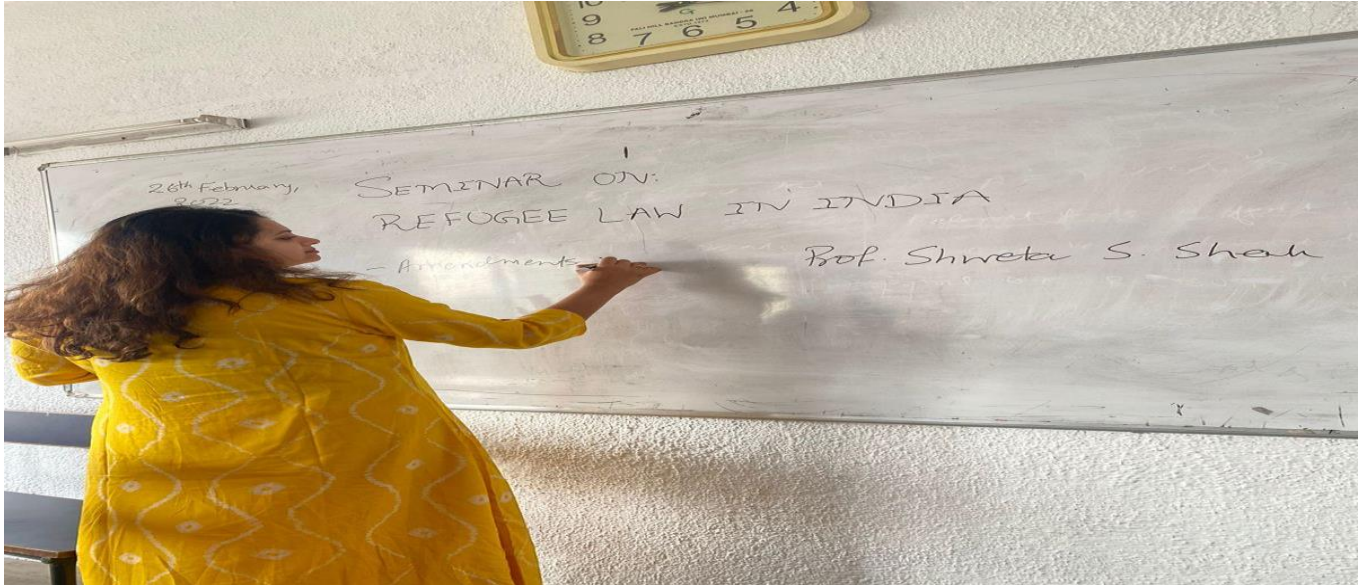

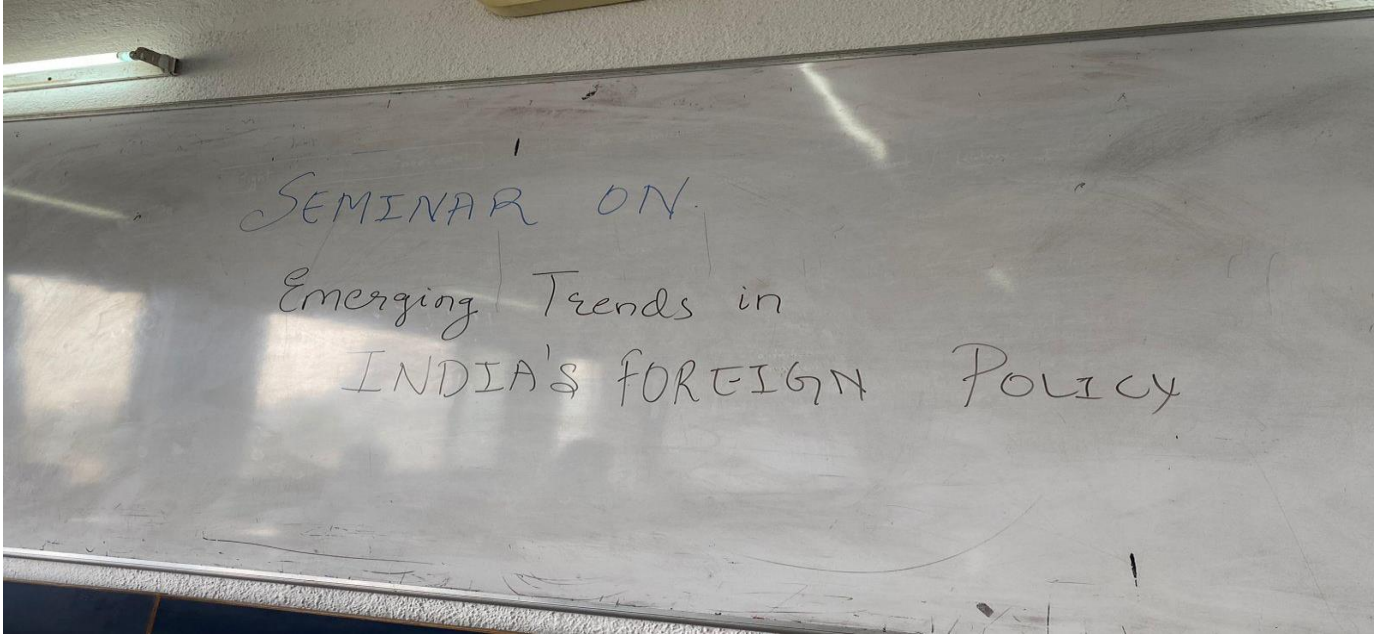

Rizvi Education Society's, Rizvi Law College organised a guest lecture for its students on the topic of "Detailed Analysis of Criminal Jurisdiction." on September 10, 2022. The guest speaker for the session was Adv. Rishi Bhuta, a counsel at the Bombay High Court.

The event commenced with a welcoming speech by Mr. ShubhkeshDube, President of Student Bar Forum.. The honourable guest speaker, Adv. Rishi Bhuta, along with the honourable Principal of the college, Dr.Sajan G. The lecture attracted a total of 100 students.

Adv. Rishi Bhuta began by providing a comprehensive overview of the various fields of the practice area of law he is indulged in, including POCSO, MCOCA, NDPS and MPID Act. He swiftly flowed into the various classes of Criminal Courts in India which are- the Supreme Court, High Courts, Sessions Court, etc.

With a dive into each court's jurisdiction, he gave a case example which he either personally dealt with or has been a well renowned case associated with that particular court. In no said order, he began with the Sessions court which is headed by a Sessions Judge and is the highest criminal court in the district. It may pass any sentence authorised by provisions of law, but a death sentence, passed by it, has to be confirmed by the High Court.

With regards to Special Courts, he spoke of how the 14th Finance Commission in 2014 recommended establishing 1800 'fast-track courts' between 2015-2020 to expedite "cases of heinous crimes; related to women, children and senior citizens". These fast-track courts are also a type of special court as they adjudicate some instances in the hope that these cases will be disposed of faster. In an entirely separate proceeding in 2019, the Supreme Court also ordered that an exclusive special court for POCSO cases be established in each district with more than 100 POCSO FIRs.

Description

On September 17, 2022, Rizvi Education Society's, Rizvi Law College conducted a seminar for their students. The seminar focused on the application of the Code of Civil Procedure (CPC), writs, Public Interest Litigation (PIL), and the Rights of Persons with Disabilities (RPWD) Act, to learn about the concepts and principles of civil procedure code, writs, public interest litigation and rights of persons with disabilities act and their relevance and application in legal practice and social justice.

He also gave examples of the five kinds of writs, namely, habeas corpus, mandamus, prohibition, certiorari and quo warranto, and their scope and limitations.

He further explained the concept and significance of Public Interest Litigation (PIL), which is a legal action initiated by any person or group in the public interest for the enforcement of any constitutional or legal right

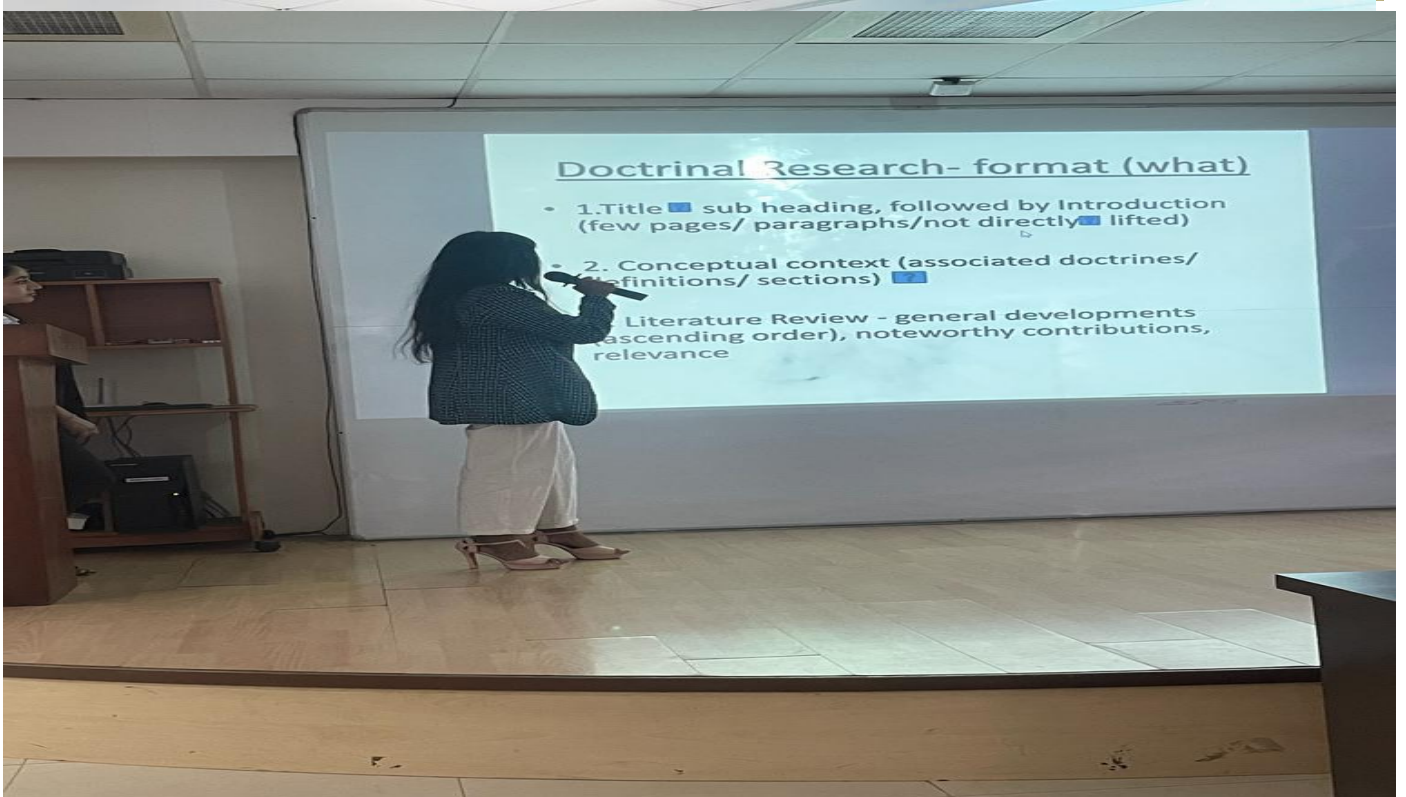
