### **-DOAJ:**

The **Directory of Open Access Journals (DOAJ)** is a website that hosts a community-curated list of open access journals, maintained by Infrastructure Services for Open Access (IS4OA). It was launched in 2003 with 300 open access journals. The mission of DOAJ is to "increase the visibility, accessibility, reputation, usage and impact of quality, peer-reviewed, open access scholarly research journals globally, regardless of discipline, geography or language.

In 2015, DOAJ launched a reapplication process based on updated and expanded inclusion criteria. At the end of the process (December 2017), close to 5,000 journals, out of the 11,600 indexed in May 2016, had been removed from their database, in majority for failure to reapply.

Notwithstanding the substantial cleanup, the number of journals included in DOAJ has continued to grow,

## Databases:

In computing, a database is an organized collection of data or a type of data store based on the use of a database management system (DBMS), the software that interacts with end users, applications, and the database itself to capture and analyze the data. The DBMS additionally encompasses the core facilities provided to administer the database. The sum total of the database, the DBMS and the associated applications can be referred to as a database system. Often the term "database" is also used loosely to refer to any of the DBMS, the database system or an application associated with the database.

Small databases can be stored on a file system, while large databases are hosted on computer clusters or cloud storage. The design of databases spans formal techniques and practical considerations, including data modelling, efficient data representation and storage, query languages, security and privacy of sensitive data, and distributed computing issues, including supporting concurrent access and fault tolerance.

Computer scientists may classify database management systems according to the database models that they support. Relational databases became dominant in the 1980s. These model data as rows and columns in a series of tables, and the vast majority use SQL for writing and querying data. In the 2000s, non-relational databases became popular, collectively referred to as NoSQL, because they use different query languages.

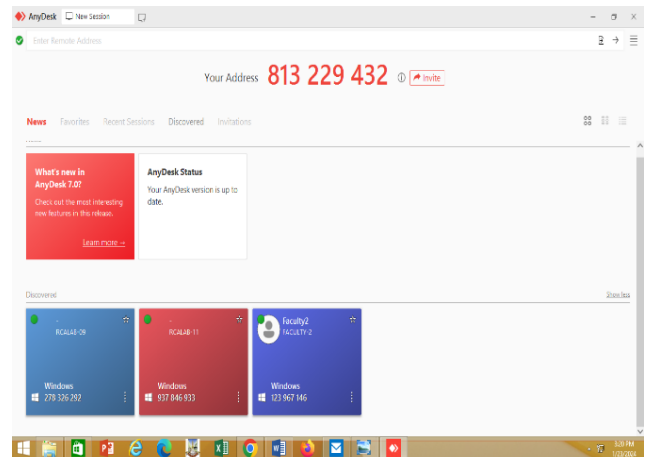
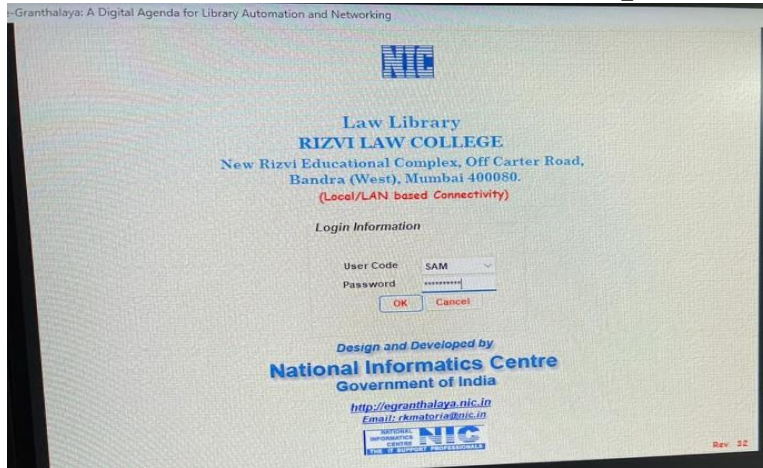

Remote Access in simple language is the ability to access a computer / server remotely through a network connection. The users have leverage to work remotely away from the institution/ office while retaining access to a distant computer or network. Remote Access can be applicable for Local Area Networks (LANs), Wide Area Network (WANs) and Virtual Private Networks (VPN). Connection to a data-processing system from a remote location, for example through a virtual private network or remote desktop application Remote desktop software, refers to a software or an operating system feature enabling applications to be run remotely on a server while being graphically accessible locally. Direct (Physical) Line: Through the direct line control can be implemented between a computer and institution LAN. Similar line can be used to connect a home LAN and an institution LAN. This network is faster but is more expensive and have high maintenance. The network has routing limitations due to structure of routing from point to point. Virtual Private Networks: VPN connects to remote site through the internet with encryption and tunnelling techniques to access the institution network. VPN is generally used in small organizations.

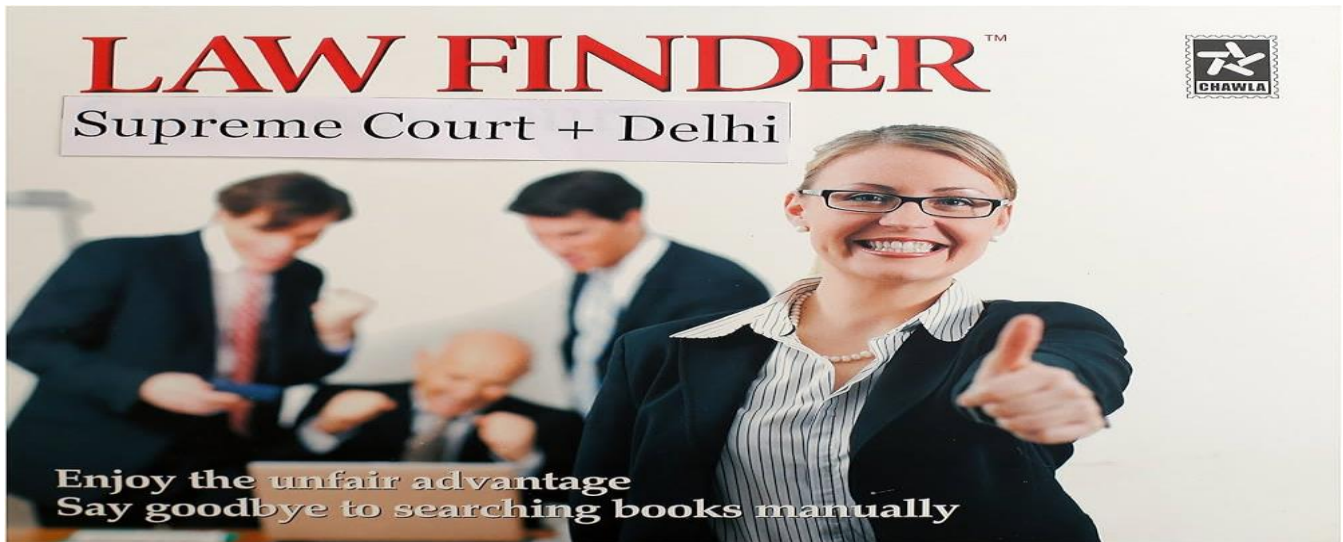
